

PRIVACY POLICY

In accordance with the Personal Data Protection Act 2010, we would like to inform you on what and how personal data is collected and further processed. We recommend you to read this Privacy Policy so that you understand our approach towards the use of your personal data.

By submitting your personal data to us, you will be treated as having given your permission, where necessary and appropriate, for disclosures referred in this Privacy Policy. If you provide us with personal data of other individuals, you hereby represent that you have obtained consent from that individual prior to providing their personal data to us. References to 'your personal data' in this Privacy Policy would include such individual's personal data that you provided to us.

V GALLANT LIMITED [BVI Company No: 2156042] and / or its group of companies ¹(**"V Gallant Group of Companies"**) will only retain the personal data you have supplied for as long as is necessary to achieve the purposes outlined in this Privacy Policy and in line with its data retention guidelines. We will take all reasonable steps to ensure all personal data is destroyed or permanently deleted if it is no longer required for the purpose for which it is to be processed.

"V Gallant Group of Companies", "we", "us" or "our" means V Gallant Group of Companies and/or its group of companies. "Personal Data" means any information in our possession or control that relates directly or indirectly to you to the extent that you are identified or identifiable from that information or from other information in our possession, including but not limited to 'sensitive personal data'.

WHAT DOES THIS PRIVACY POLICY COVER?

This Privacy Policy is to inform you regarding the use of your personal information which is collected when visiting this website or any of our websites and / or when you sign up for any of our products and/or services, submit any forms or otherwise enter into a transaction with us, affiliate, dealership and other related program or such other promotional events requiring your personal data.

PURPOSES OF THE COLLECTION OF YOUR DATA

We collect and use personal information (including name, address, telephone number and email) to better provide you with the required services, or information or our promotional or latest products. We would therefore use your personal information in order to:

- update or send you on the latest products and information or items on offer or special promotion
- respond to queries or requests submitted by you
- process orders or applications submitted by you
- administer or otherwise carry out our obligations in relation to any agreement you have with us
- anticipate and resolve problems with any goods or services supplied to you
- create products or services that may meet your needs
- statistical analysis
- customer administration
- profiling service preferences
- finance and marketing operations and activities and / or as required in the provision of our services but not limited to credit control services
- in compliance with any regulatory, statutory or legal obligation imposed on us by any relevant authority
- to comply with any order of court or directive from authorities investigating any alleged fraud, misdeed and / or abuse or to enforce any of the terms in our website terms of use and notices or, where such action is necessary to protect and defend the rights or property of V Gallant Group of Companies.
- to conduct market research of users of our products
- If we wish to use your personal information for new purposes, we will offer you the means to consent to those new purposes.

To optimise our services we may wish to use your personal data for direct marketing. As we respect your privacy we will only use your personal data for this purpose when you are aware thereof and if required we will request your consent prior to using your personal data for direct marketing. Please note that the supply of personal data by you is voluntary.

Additionally, if at any time you wish us to stop using your information (or the information of another person who may be identified from your information) for any or all of the above purposes, please contact us as set out below. We will stop the use of your information for such purposes as soon as it is reasonably possible to do so.

In addition, the collected personal data will be transferred to selected third parties, and / or our subsidiary or related companies which may be located outside of Malaysia as part of the services offered to you through our site.

These third parties will not use your personal information for any other purposes than what we have agreed with them. We will request those third parties to implement adequate levels of protection in order to safeguard your personal information.

We respect your personal information and therefore, we will take steps to ensure your privacy rights continue to be protected if we transfer your information outside of Malaysia in this way. In addition, if you use our services while you are outside Malaysia, your information may be transferred outside Malaysia in order to provide you with those services.

USERS UNDER 18

Personal Information Collection

We do not monitor or permanently store third party information save for the purpose of accounting, billing or record keeping, or unless required by law.

SECURITY OF YOUR PERSONAL DATA

As we value your personal information, we will ensure an adequate level of protection. We have therefore implemented technology and policies with the objective of protecting your privacy from unauthorized access, improper use, unlawful destruction or accidental loss. All our employees and data processors, who have access to and are associated with the processing of personal information, are obliged to respect the confidentiality of your information

In those cases, personal information that may identify you will not be transferred to the third party. All communication whether from us or our business partners will be sent to you by us.

In such situations, we will share your personal information as is necessary for the authorised third party to perform these services, on a strictly confidential basis. COOKIES POLICY

We use the term “cookies” to refer to cookies and other similar technologies covered by the EU Directive on privacy in electronic communications.

Cookies are small data files that your browser places on your computer or device.
